Before applying:

Ask yourself:

- WHAT ISSUE, UNFULFILLED NEED OR PROBLEM WILL THE PROJECT BE ADDRESSING?
- DOES THE PROJECT BENEFIT THE COMMUNITY OR JUST YOU/YOUR ORGANISATION?
- WHY CANT YOUR ORGANIZATION FUND IT?
- CAN ANYONE ELSE HELP FUND IT?
- CAN YOUR ORGANISATION DELIVER THE PROJECT?

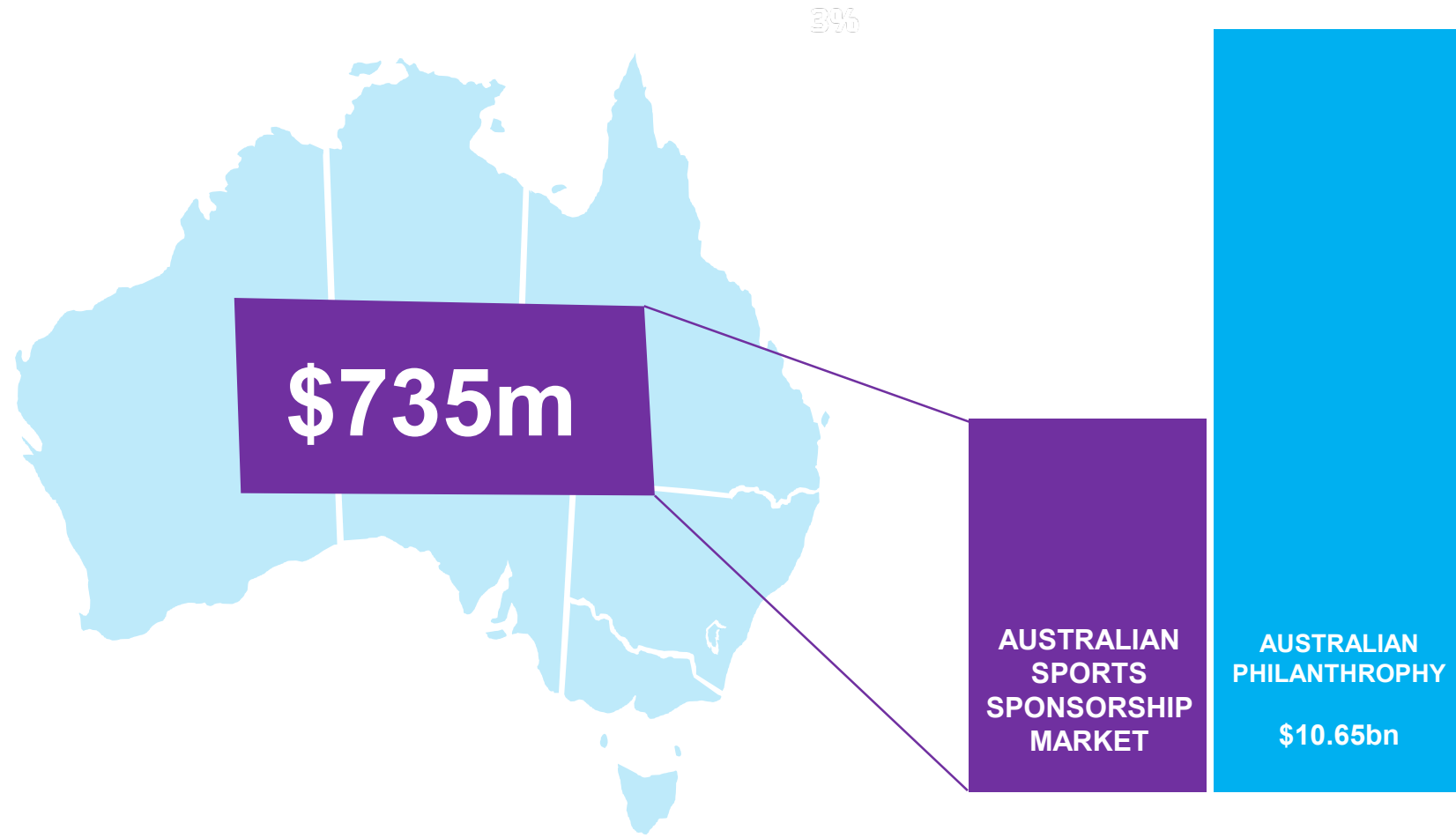

The Regional Arts Development Fund (RADF) is a partnership between the Queensland Government and Noosa Shire Council to support the development of local arts and culture in regional Queensland.

RADF supports local arts and cultural development opportunities by providing one-off, short-term, project-based financial assistance to groups, individuals and businesses.



RADF Process



1. Have a project idea
2. Read guidelines and application form
3. Talk to a grants officer
4. Hone your idea and gather support information – quotes, budget, artist eligibility and participation form etc.
5. Fill out application form (online – SmartyGrants)
6. Ask for help if you need it
7. Submit application
8. Await outcome

- provide benefit to Noosa

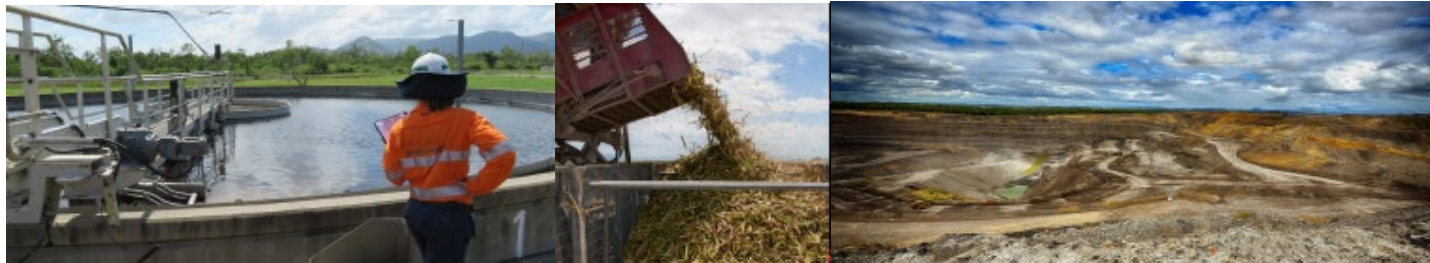

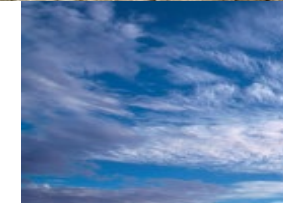

DES Community Sustainability Action Grant

- \$18 million over six years to eligible community groups and individuals for innovative projects which seek to address climate change, conserve Queensland's natural and built environment and protect our unique wildlife;
- Previous rounds included Koala research, environmental conversation, heritage protection and protecting threatened species;
- Over \$4million will be allocated through targeted rounds in 2019/20;

Engaging Science Grants



- Engaging Queenslanders in Science.
- More grants in the next 12 months to be announced in the coming months.
- Grants of up to **\$10,000**.

Grant focus areas include:

- increase the number of students participating in school STEM (science, technology, engineering and mathematics) subjects
- encourage Queenslanders to join in science-based activities
- promote scientists directly engaging with the Queensland community
- create awareness of the great science taking place in Queensland.

Citizen Science Grants

- Increase public participation in Queensland scientific research
- More grants in the next 12 months to be announced in the coming months
- Grants of up to \$30,000 (over a 3 year period) through Office of the Queensland Chief Scientist



Grants to be aligned with Queensland Citizen Science Strategy goals:

- Raise awareness: help communities have an understanding of citizen science projects relevant to Queensland
- Make it easier to find and participate in projects and for scientists to recruit and train citizen scientists;
- Improve access to data/outcomes
- Grow no. of citizen scientists and scientists working together to make scientific discoveries.

Community Benefit Fund Grants

- QLDs largest one-off community grants program, distributing approximately \$55 million per year
- Grants available for not-for-profit community groups, to enhance their capacity to provide services, leisure activities and opportunities for Queensland communities
- Grants from \$500 to \$35,000
- Previously has included:
 - Purchase of equipment and/or facility improvements;
 - Funding for community events, training, workshops, festivals

FairPlay vouchers

- ✓ New program which replaces the “Get Started Vouchers”
- ✓ **More activities**
- ✓ 56,000 vouchers available
- ✓ Two rounds per year



Applying for a FairPlay voucher



Key Dates:

31 July 2019 – Round 1 opens at 8 am.

9 October 2019 – Round 1 closes, unless all vouchers have already been issued.

13 November 2019 – Vouchers expire and must have been presented to an activity provider.



Is your child eligible?

- ✓ Queensland resident aged from 5 to 17 years (inclusive).
- ✓ Has not received a Get Started voucher this year.
- ✓ Applicant must hold a Valid Department of Human Services [Health Care Card](#) or [Pensioner Concession Card](#) with the child's name on it, or is identified by a registered referral agent.
- ✓ *If your family does not have a Health Care, Pensioner or Concession card or is able to be referred by a referral agent, there may still be an opportunity to apply for a voucher if your combined family income is less than \$55,000. Further details on this registration process will be on the website when it is available.*



How do I apply for a FairPlay Voucher?

- ✓ Register for a **QGrants** account.
 - ✓ This step can be completed before 31 July 2019.
- ✓ Apply for a FairPlay voucher using your QGrants account once the program is released at 8.00 am on 31 July 2019.

Referral Agents

- ✓ Previous referral agents do not need to re-register.
- ✓ Referral agents can include:
 - ✓ Youth Justice and Child Safety officers
 - ✓ Community health workers
 - ✓ School/deputy principal or school guidance officer
 - ✓ Police officer (who works with children/families in need).

To become a referral agent you will need to complete the online registration form.

To become a registered activity provider, your organisation must meet all of the following criteria:

- ✓ have a valid and current **Australian Business Number** (ABN) or be incorporated under the **Associations Incorporation Act 1981** with an Incorporated Associations (IA) number

be either:

- ✓ a Queensland sport and active recreation organisation (excluding unincorporated not-for-profit organisations) affiliated with one of the listed [State or National Level Organisations](#) listed for FairPlay vouchers
- ✓ an incorporated not-for-profit community organisation providing physical activity as part of its programs
- ✓ a [State or National Level Sporting Organisation](#)
- ✓ a P&C Association established under the *Education (General Provisions) Act 2006*.

provide one or more activities that are:

- ✓ listed as an eligible activity on the [activity provider directory](#)
- ✓ delivered by the organisation in the State of Queensland
- ✓ provided by the organisation over a (minimum) series of 8 weeks/sessions
- ✓ have and maintain suitable public liability and team/participant insurance
- ✓ meet the [Queensland Blue Card requirements for persons working with children](#)
- ✓ ensure that the eligible activity/ies are conducted by appropriately qualified persons, including (but not limited to) coaches, instructors, referees, managers and first-aid officers (where applicable).

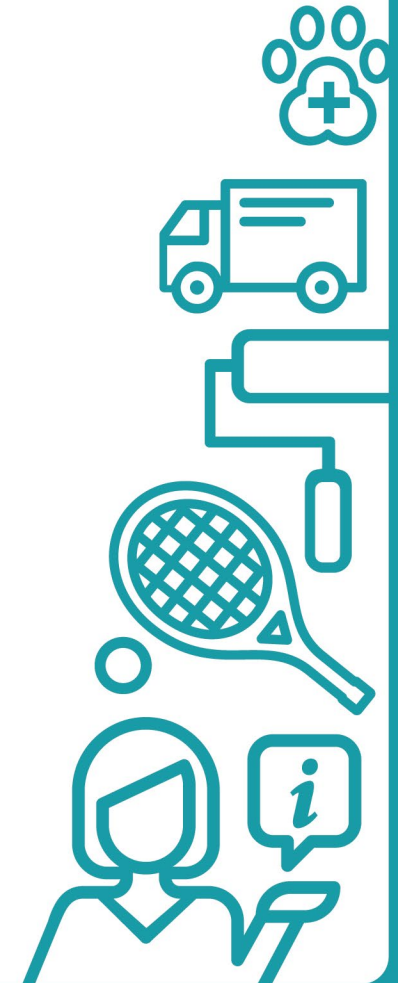

Read the funding guidelines – each round.

Decision – Is my organisation eligible? It must ...

Have not-for-profit objectives

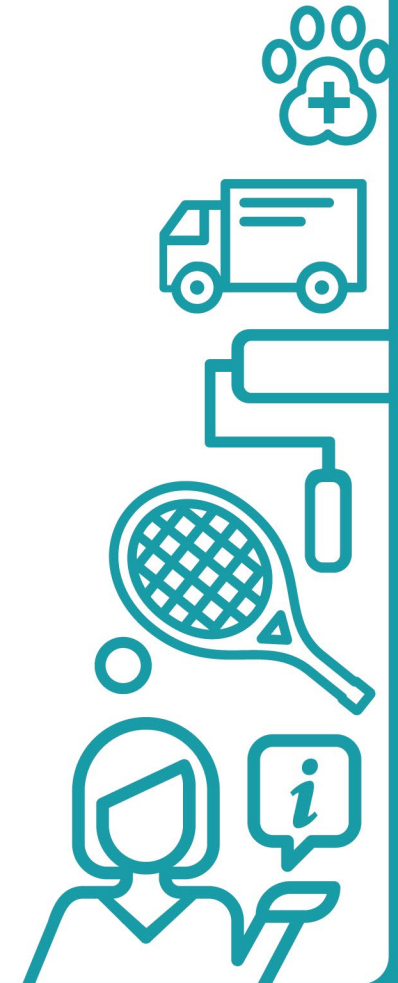
Be incorporated or registered by an Act of Parliament

Have an active ABN

If sponsoring, accept financial and legal responsibility for the application and grant.

Decision – Is my organisation ineligible? Yes if it is ...

Proprietary limited or public companies limited by shares.



Ineligible budget items

Items purchased before the grant is approved.

Grant writer and project management fees.

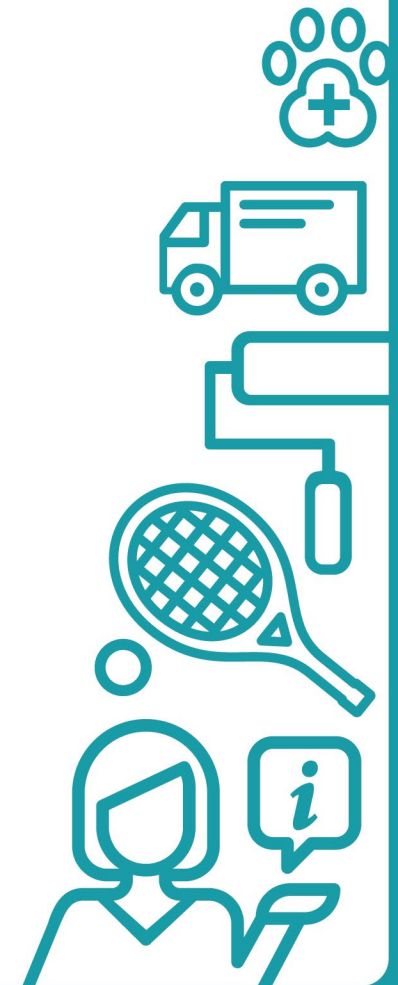
Repayment of debts.

Overseas travel.

Goods or services that benefit an individual.

Gifts, Alcohol

Refer to the funding guidelines for a complete list.



Decision - Consider the funding priorities:

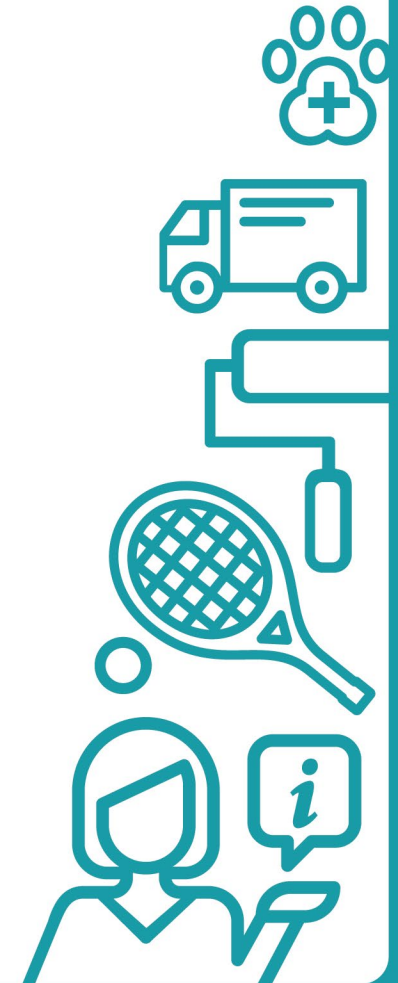
Priority 1 – Organisation affected by natural disaster

Priority 2 – Facility improvements or equipment

Priority 3 – Vehicles (bus, car, caravan, boat etc)

Priority 4 – Community events, training, workshops, programs and festivals

Priority 5 – Organisations that have received GCBF funding of \$15,000 or more in the last 2 years.



Decision – Consider the other determining prioritisation factors:

Financial position and age of organisation

Value for money of the grant

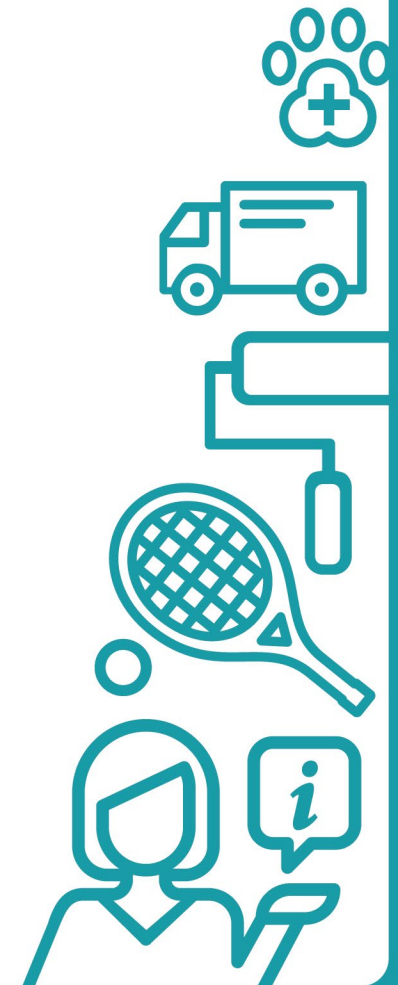
Contributions toward project

Ability to generate income

Benefits to more than one organisation

Geographic location and benefit to region

Target group being assisted



Assessment

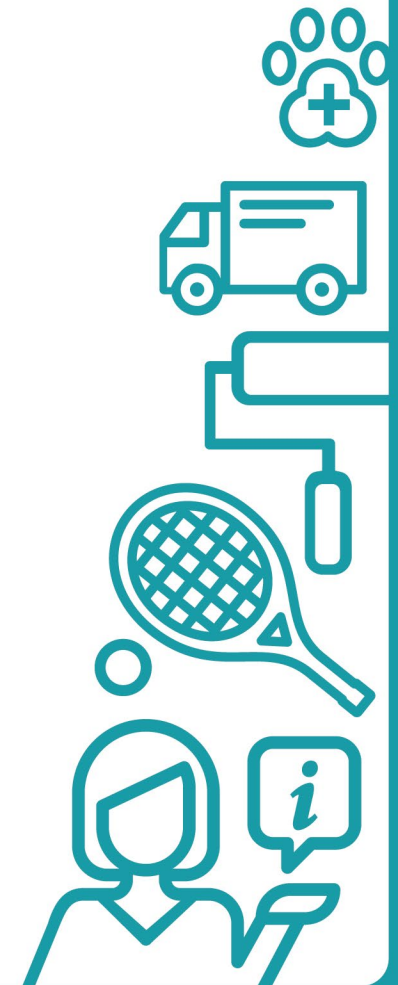
Your application will:

Be assessed against the funding guidelines.

Be presented to the Gambling Community Benefit Committee for consideration and recommendation (eligible only).

Be provided to the Attorney-General for consideration and approval (recommended only)

Receive an outcome approximately five months after the closing date.

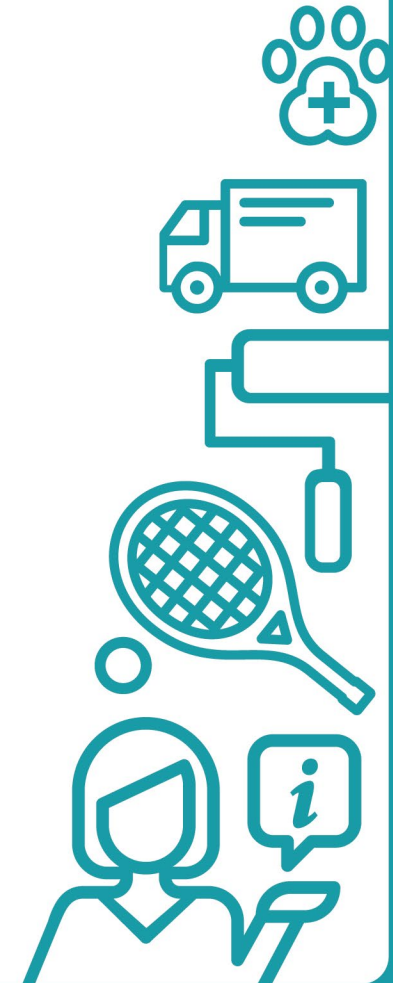

Energy Efficient Communities Program

- ▶ \$50million of grants from Federal Government
- ▶ Support community organisations to save energy (and \$\$)
 - ▶ Energy generation (solar PV) & storage (batteries)
 - ▶ Energy management systems
 - ▶ Energy assessments
- ▶ October 2019 - grant applications open for Solar/batteries
- ▶ Early 2020 - grant applications open for other equipment upgrades & energy audits

So get in **FIRST** - BE PREPARED

- ▶ Organise a **FREE** ecoBIZ assessment
- ▶ Identify solar PV and battery requirements
- ▶ Obtain 3 quotes
- ▶ Develop application in accordance with guidelines
 - ▶ *WE CAN ASSIST*
- ▶ Submit application as soon as applications open

FIRST IN FIRST SERVED

- ▶ Useful for other grants in any case
