### FREQUENTLY ASKED QUESTIONS

People have many questions when it comes to reserving a grave or ashes site in one of the Noosa Council cemeteries. The questions below represent the most frequently asked, however should you have a question or query not listed, please contact the Noosa Council on (07) 5329 6500 or email [mail@noosa.qld.gov.au](mailto:mail@noosa.qld.gov.au)

#### 1. RESERVATION FEE

The reservation fee holds the plot until the time of interment only. The reservation fee paid is a one-off fee, and the fee is non-deductable from the interment fee. (Additional fees apply at time of interment).

#### 2. What does my site reservation cover?

Your site reservation covers the costs associated with reserving the site until date of use only.

#### 3. Can I pre-purchase my grave or ashes site?

No. You can only reserve a grave or ashes site.

#### 4. Does my site reservation include the headstone or memorial?

No. At the time of interment there will be additional fees including interment fee and memorialisation fee.

#### 5. I would like my partner placed in the same site as myself, is this possible?

Yes, in most circumstances all interment positions are prepared for 2 burials. Some restrictions apply in certain cemeteries, but this is advised at the time of reservation. If required there will be a fee for additional burial/interment.

#### 6. Do I own my grave or ashes site?

No, you reserve the Burial rights to that grave or ashes site, therefore, becoming the burial/ashes rights holder. The land remains in the administration of the Noosa Council, however, only the burial/ashes rights holder can authorise burials or ashes and memorial additions.

#### 7. Am I able to choose the location of my grave or ashes site?

Yes. A council officer can meet you onsite to discuss the available locations.

#### 8. Can I sell the rights of my grave or ashes position to another person?

No, your position may only be returned to council. You are not able to sell your position to another person.

#### 9. When I pass away what is required for my family to use my site?

At the time funeral arrangements are completed, a copy of the "Reservation Certificate" is required to be forwarded to the council office for verification. This can be done through your funeral director.

#### 10. Why should I reserve a grave or ashes site?

The reservation of a grave or ashes site removes the burden on your family to choose a location for your burial.

#### 11. Doesn't my prepaid funeral plan already cover this cost?

We cannot advise you regarding the numerous funeral plans available. You would need to contact the insurance company/funeral company direct to confirm exactly what is covered by your individual plan.

#### 12. RSL site – I would like to reserve a site in the RSL section of the cemetery?

All RSL reservations must be applied for via the relevant RSL Sub Branch.
