1. Welcome by Chairs

The meeting commenced at 5:32 pm.

Welcome by Noosa Council CEO Scott Waters.

Scott acknowledged the Noosa River and catchment as home of the Kabi Kabi people as the Traditional Custodians, whose lands and waters we all now share.

2. Apologies

Apologies were tabled from Mayor Clare Stewart, Agnes Reed, Peter Hunnam and Grenville Snowden.

3. Conflict of Interest Declarations

No conflicts of interest were raised by Committee members.

4. Introductions of new Committee Members

Erica introduced herself as a new Committee member representing the local commercial recreational tourism community.

Richard Wilschke introduced himself as a new Committee member representing the local commercial recreational tourism community.

5. Confirmation of 6 April 2022 meeting minutes

Minutes were accepted.

Outstanding actions:

- Kell Dillon anchoring, mooring and liveaboards (to be discussed as per Agenda Item 8)
- War on Wrecks

Kell Dillon noted that the War on Wrecks program has removed 1,010 abandoned vessels, 596 of which were removed by contractors and 414 by owners. On the Sunshine Coast 83 vessels have been removed since the beginning of the program in 2018, with 35 of these vessels removed from the Noosa River. MSQ has dedicated 11 full time officers to this program.

Paradise Seaplanes

Scott Waters confirmed that he had received correspondence from Paradise Seaplanes regarding their proposal. He questioned their reasoning for moving the business to the Noosa River when it was thriving in the Mooloolaba River. He is open to further discussion, acknowledging that this proposal was not in alignment with Council policy.

Hydrological Study

Amy Kimber noted that according to the Noosa Council infrastructure team, hydrological studies have been undertaken previously. Rebecca Britton confirmed that a Noosa River Flood Study update was in process, including flood extents, flood heights, hydrology of the river and behaviour of the river more broadly.

• Shoreline Erosion Management Program

Amy Kimber confirmed that permits and contractors are still being considered for this program, with updates unable to be provided until these have been approved.

6. Confirmation of 9 May 2022 Sub-Committee Meeting Minutes

Minutes accepted.

7. Correspondence

The items of correspondence received included an email from Bruce McLean on 8 March 2022 regarding a media statement from NRSAC on the MSQ speed review. Amy Kimber noted the email had been responded to.

Amy Kimber has received several phone calls from applicants who had applied to be on the NSRAC. Correspondence was received from Gwen Gilson who expressed concern regarding the lack of scientific representation on the Committee. There was a need to prioritise representation from the tourism sector, hence the appointment of the two new Committee members from this sector.

8. Options to address Anchoring, Mooring and Live Aboard issues in Noosa River (MSQ)

MSQ outlined the initiatives which have been undertaken to address waterways management for the Noosa River so far. These included:

- The assignment of one permanent MSQ staff member to Noosa and the allocation of an office and vehicle as well as the delivery of a new vessel in May 2022 to support the waterways management work on the Noosa River.
- A Noosa Enforcement Program commenced in May 2022. This program requires the Maritime Enforcement Team (MET) to undertake a coordinated and targeted enforcement

program to address waterway issues in the Noosa River. It involves a 6 month on-water campaign with 75 percent of weekends patrolled by either the MET or the Sunshine Coast Water Police. Initial and early results of the enforcement program to date were presented to the NRSAC meeting.

MSQ acknowledged the NRSAC recommendations for changes to anchoring and mooring regulations in the Noosa River. It was noted that MSQ and Noosa Council officers had engaged in extensive consultation to build proposals for forward consultation.

In response to the NRSAC recommendations, MSQ presented a proposed management plan for the Noosa River to the NRSAC for initial consideration. The proposed management plan aims to maximise the safety and equity of access for all waterway users and is consistent with a system-wide approach to waterways management.

The NRSAC was informed that the proposed waterways management reforms will require amendments to legislation and will also require broad, formal stakeholder and community consultation to be undertaken for the progression of any potential reforms.

It was advised that the timeframe for delivery of initiatives will vary depending on the complexity and the work required to ensure that fundamental legislative principles, human rights, and adverse impacts are managed fairly. It may be possible to implement a 12-month trial period before the 2022 Christmas season (pending legislative processes).

Action: MSQ's proposed measures will be taken to a Sub-Committee meeting for further discussion, with initial feedback on the proposals to be provided to MSQ and Noosa Council.

9. Update on Speed Review

Consultation for the Noosa River Speed Review has been largely completed (phase 1). It is MSQ's intention to return to key stakeholders and seek feedback on any compromise to the original speed limit proposal.

10. Outstanding operational business requiring resolution

• Council bathing reserves

Committee member Jane Harris informed the Committee of potential safety issues from the public fishing at Council bathing reserves, suggesting that fishing and the use of boats should not be allowed in these areas.

• Installation of hitching posts

The Committee discussed installing hitching posts and designated areas for boats to allow for brief stops. Currently, some vessels are being tied to trees on the banks of the river (such as Lion's Park) which poses both environmental and safety hazards.

• Parking limits

The Committee discussed implementing parking limits on parking bays located next to the river. Members of the public have been observed parking cars and trailers for extended periods of time, leaving rubbish in the area and not sharing facilities with other users.

Committee member Noel Playford suggested that local government issues such as the above were not appropriate to discuss at Committee meetings co-chaired by the General Manager of MSQ. Noel left the Committee meeting before it had finished and stated that he would not be back.

11. General Business

Scott Waters proposed ending the meeting on time and carrying outstanding Agenda items to the next meeting. He acknowledged Shaun Walsh's role as A/Environment Services Manager, and thanked Shaun for his support, encouragement, and contribution upon Scott's appointment as Noosa Council CEO and Co Chair of the Committee. Rebecca Britton will be taking over as A/Environment Services Manager.
