# **Noosa River Stakeholder Advisory Committee**

#### 1. Welcome by Chairs

The meeting commenced at 5:39pm.

Welcome by Noosa Council A/CEO Larry Sengstock.

Larry acknowledged the Noosa River and catchment as home of the Kabi Kabi people and the Traditional Custodians, whose lands, and waters we all now share.

#### 2. Conflict of Interest Declarations

No conflicts of interest were raised by Committee members, and the Code of Conduct was taken as noted.

### 3. Confirmation of 24 October 2022 meeting minutes

Minutes accepted with changes from Jane Harris.

#### 4. Correspondence

MSQ has received a Ministerial on speed and will be responding directly to James Hordern.

Peter Hunnam questioned the purpose of going through the correspondence when the Committee is drawing to a close.

## 5. MSQ - Management Plan for the Noosa River public consultation

17% non-compliance, 17 year old girls on PWCs, no safety vests, speeding. Proposal being noticed by other waterways and needs to adopt a system-wide approach. Broad outline of public consultation provided.

Consultation normally runs for 4 weeks but longer timeframe provided to maximise opportunity for input. Two face-to-face consultations and online survey. 858 online survey responses, 60 email submissions, approximately 140 people attended face-to-face sessions. 83% of respondents live in Noosa Shire, 38% do paddling and/or swimming.

33% of people support almost all the changes, while only 6% were completely against them. 60% had mixed opinions. Ministerial approval required to progress the proposed changes and supporting

infrastructure such as pump out facilities, boating infrastructure and technology including cameras will be investigated to support changes.

Recreational boating facilities consultation is also underway. Apps such as Decking could be used to track vessels. Technological solutions to make waterways safer.

Peter Wilkins commented the guiding principles are equity of access, safety and the environment with an approach that contributes to the sustainable management of the waterways. Better signage needed.

Nick asked about proportion of those for and against and what's the tipping point for MSQ implementing the changes. Ultimately it will be a Ministerial decision. Michael commented on the number of respondents – large majority to not anchor or moor a boat in the Noosa River.

QUT analysed the data and applied statistical analysis to the quantitative data. Peter Wilkins noted 60% of respondents were 'beige', the figures presented do not represent the qualitative data. Proposed solutions may have unintended impacts on other waterways and the intention will be to avoid any unintended consequences.

Joanne noted NBFA is still not registered as an incorporated organisation, so it's important MSQ does not give undue weight to particular submissions.

Peter Hunnam noted suggestions were provided on a range of river management issues – broad recommendations around maintaining the natural and tranquil nature of the river. He asked what criteria will be used to weight submissions.

Kell noted a lot of work has been done already to develop this proposal. Safe outcome overlay is the main objective. Timeframe for finalisation expected to be October.

Michael noted MSQ won't be able to implement all the proposals at once and likely that the proposals that have the most knock-on effects will be the hardest to implement.

What MSQ is attempting to address is an unsafe waterway. MSQ is committed to implementing the final map. Revised speed proposal needed to be considered as part of the proposal. Discussion about number of submissions – previous consultation delivered 158 State-wide.

Richard asked whether eco-friendly moorings will be considered. Kell noted there is a lot more information now available about seagrass and these will be considered.

DES and other agencies will need to be involved in mooring planning. Nick queried whether mooring cap will be maintained. Peter Wilkins noted the final map is stage 1 but for now the mooring cap will remain in place.

War on Wrecks program is now up to 1165. 40% of people deal with the vessel themselves.

Phil asked how this will affect houseboats near Lake Doonella. Gary noted the 60m zone will mean they will have to move. Michael noted this is probably the most important issue the public would like to see addressed.

Nick thanked MSQ on behalf of the Committee for progressing the proposal, and Council staff. Bruce agreed, from the Committee's perspective this is a starting point.

Bruce asked whether MSQ would consider speed cameras on the river.

Michael noted the importance of getting the messaging right – explain the key outcomes MSQ is trying to achieve so that people can regulate their behaviour to prepare for the changes. The danger is if the word on the street disappears off the radar.

Nick asked if Council would keep the Committee informed if there are any changes to the proposal. Peter Wilkins noted the reforms still need to go through the Office of Best Practice Reform.

Peter Wilkins confirmed reforms will not go to Parliament, Minister will sign off, then reforms will be prioritised for implementation. MSQ will need to continue working with Council to implement. Peter Hunnam asked whether the houseboat issue could be resolved immediately rather than waiting for another year to bring about legal changes.

Nick asked whether QPS will be brought in to assist. Multi-agency response required. Kell confirmed the map is public. Kell and Sally-Anne discouraged members from promoting the outcomes of the public consultation as there is more analysis still to be done.

If asked, Committee members can refer members of the public to MSQ. Phil encouraged MSQ to communicate with the public sooner rather than later.

Nick suggested Council publicise the outcomes on its website.

Amy thanked the Committee for their commitment and hard work. Agnes acknowledged Nick's role in guiding the Committee. Phil acknowledged MSQ for its commitment. Joanne noted lots of feedback has been taken on board. Phil acknowledged Jake, Shaun and Amy. Nick noted diversity of group and success in getting proposal underway, passion of the group. Kell thanked the Committee and MSQ staff for their skill in navigating a complex issue. Joanne noted it's been difficult not being able to talk to the community.

Michael suggested the Committee term could have been shorter and more impactful - 6 months. Phil agreed the Committee is far too large.
