Upon receipt of the signed declaration and accompanying documentation council will review the Differential General Rate Category.

5. Information

Adjustments will only be made within the current rate period. It is the owners' responsibility to check that all rates and charges are correct at the time of issue of the rate notice. Adjustments will not be made for prior financial years where a property has been categorised as not a principal place of residence and the owner/s have not provided a declaration that the property is their principal place of residence.
